LOGO

The WEBTOON CANVAS CREATOR COLLABS Logo should always deliver a consistent brand image by using the brand color green.

The green WEBTOON CANVAS CREATOR COLLABS Logo should be primarily used at all times.



A white WEBTOON CANVAS CREATOR COLLABS Logo can be used against a green backdrop.



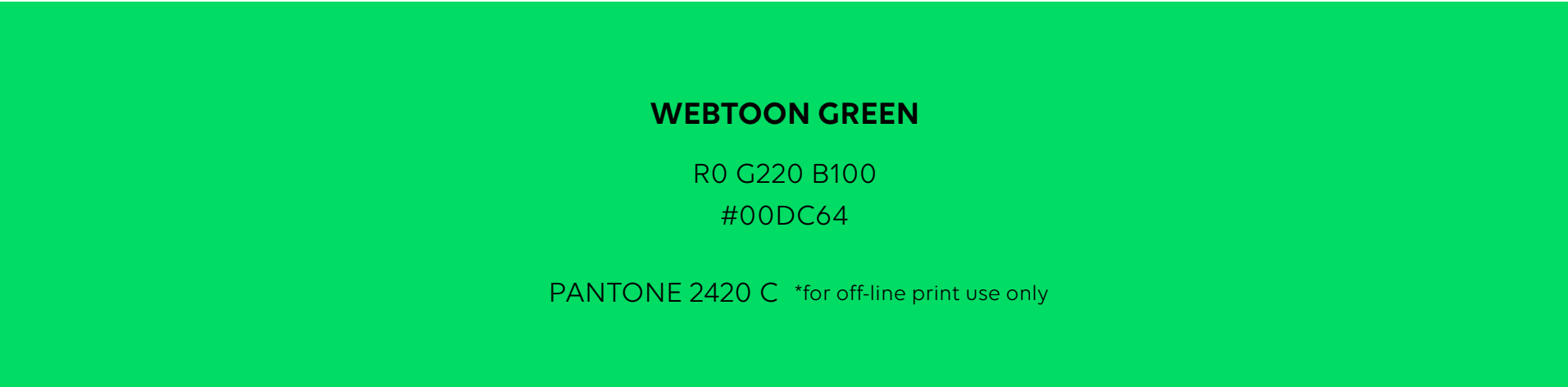
USAGE EXCEPTIONS

The WEBTOON CANVAS CREATOR COLLABS Logo should be used in the brand's green color as a general principle. Use of the white WEBTOON CANVAS CREATOR COLLABS Logo is permitted only in the special cases specified below.



- When sufficient color contrast between the background and the logo cannot be ensured.
- When background modification is not possible and logo legibility is compromised.
- When the use of the color logo is restricted and logo placement is required.

You can clip images into CREATOR COLLABS, Do not alter the WEBTOON CANVAS logo.



You can heavily stylize CREATOR COLLABS and add floating elements.



You can overlap elements against the WEBTOON CANVAS logo.



You can change CREATOR COLLABS' color different from the color regulation.
